# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to thetreasuredtrunk.com and The Treasured Trunk and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to The Treasured Trunk include thetreasuredtrunk.com. The The Treasured Trunk website is a Nonprofit site. By using the The Treasured Trunk website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, The Treasured Trunk may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase The Treasured Trunk's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
